cause great harm if it was used by the wrong means. In some states, people can purchase even without a gun permit. How can you trust a person with a gun that doesn't have any training?


Even if people use guns for a proper situation such as self-defense, they can still hurt themselves or innocent people since they have no gun experience.

With the advantage of easy access to firearms, it also comes with a major problem in the United States, gun violence. Based on the article "Gun Violence in the US Far Exceeds Levels in Other Rich Nations" by Cedric Sam and Lindsey Rupp, stated, "Mass shootings like the horrific attack that killed 19 children and 2 teachers at Robb Elementary School in Uvalde, Texas, or the murder of 10 people at a grocery store in Buffalo, New York the week prior, are all too common in the US". Due to the lack of regulation and restriction on firearms, gun violence became a common topic that appears on social media platforms. It is ironic since the Second Amendment was created so that people can use guns to protect themselves. Nowadays, I often hear news about shootings from social media. The closest one near my area would be the subway shooting on April 12, 2022. At that time, people were scared to ride subways and I was one of them because guns are deadly and there's nowhere that you can run away from shooters on the subway carts. I am lucky enough to not be at the scene but what about the victims that suffer from the mass shooting? The CCN news post "Survivors of mass shootings are left with lifelong wounds and mounting bills" by Christina Maxouris stated, "But those who survive the carnage are faced with not just hospital bills but the lifelong costs of an altered lifestyle: many are unable to return to work because of disabilities and may need follow-up surgeries, rehabilitation for months or years, mental health treatment and home care". The victims of the shooting events will suffer from the impact of the shooting for the rest of their lifetimes and even victims that did not get directly wounded from the attack could suffer from post-traumatic stress order (PTSD). The

damages dealt to the victims from the shooting event are unerasable and it is going to impact their households negatively. But the shooting events would not reduce and continue to occur if stricter gun laws weren't passed and enforced by government officials.

The strictness of gun laws directly significantly influences the number of homicides. There will be way fewer gun deaths when strict gun laws are enforced. According to the article "U.S. Gun Policy: Global Comparisons" by Jonathan Masters, he wrote "Gun control advocates regularly cite Japan's highly restrictive firearm regulations in tandem with its extraordinarily low gun death rate. Most years, fewer than one hundred Japanese die from gun violence in a country of 125 million people. Most guns are illegal in the country and ownership rates, which are quite low, reflect this". On the other hand, the United States has way more gun deaths. On the website EveryStat, it stated "National: 40,620 people die by guns in an average year, a rate of 12.2 deaths per 100,000 people". Based on the death rates from Japan and the United States, it is clear that stricter gun laws will lead to fewer gun deaths in a nation. There it is necessary for the

The rate of gun deaths has increased **33%** from 2011 to 2020 in the United States. This means that in 2020 there were **12,871** more gun deaths than in 2011.

In the United States, the rate of gun suicide increased **12%** and gun homicide increased **70%** from 2011 to 2020, respectively.
